## **BEQUESTS**

You may include a provision in your will or living trust in which you designate a specific dollar amount, a percentage of your estate, or specific property to the Els for Autism Foundation.

## **BENEFICIARY DESIGNATIONS**

You may designate the Els for Autism Foundation as beneficiary of any portion of the assets from your qualified retirement plan, life insurance policy, commercial annuity, or bank or brokerage accounts.

## **GIFTS OF APPRECIATED STOCK & REAL ESTATE**

One of the most tax-efficient ways to give is through gifts of long-term (owned for more than one year) appreciated stock or real estate. Gifts of stock or real estate provide:

- A charitable income tax deduction based on the current value of the property
- Capital gain tax savings

## **TAX-FREE CHARITABLE IRA GIFTS**

If you are 70 ½ years of age or older, you may make tax-free gifts up to \$100,000 per year directly from your IRA to the Els for Autism Foundation. This giving opportunity is particularly beneficial for individuals who may not need their annual required minimum distribution, are not itemizing their deductions, or who want to make a larger tax-free gift from an IRA.
